

## LAWMAKERS: FOLLOW THIS RECIPE FOR EXCELLENT EDUCATION OUTCOMES

*Invest in a continuum of equity and excellence from early learning through higher education*

**To: Governor Jay Inslee, House Speaker Frank Chopp, Senate Majority Leader Mark Schoesler, Senate Democratic Leader Sharon Nelson, & House Minority Leader Dan Kristiansen**

We appreciate the challenge before you to pass a state budget that puts Washington on the right path to a vibrant future economy with homegrown talent. Our state's economic future depends on the success of Washington students. That success requires a strong foundation in early childhood, a chance to grow and learn in an equitable K-12 system, and the opportunity to further specialize and access training, certification, and degrees in our highly-regarded system of two- and four-year postsecondary institutions.

To this end, the Cradle Through College Coalition urges you to include the following priorities in your budget proposals:

### • **Expand Access to High-Quality Pre-Kindergarten (ECEAP)**

The Early Childhood Education and Assistance Program (ECEAP) is a proven program that helps low-income children improve school readiness and long term outcomes. Open the ECEAP door for 2,700 more children in low-income families to get off to a strong start. Sustain high-quality programs and teachers by investing \$26 million in facilities and increasing the provider rate by 16% per child.

### • **Increase Access for Postsecondary Success**

Provide two- and four-year institutions with the funding necessary to keep tuition costs stable for students and offer the financial aid, advising, and support necessary for student success. Last year, 24,000 low-income students qualified for the State Need Grant, but funds were not available to serve them. Fully fund the State Need Grant so that lack of financial aid does not cut Washington students off from the opportunity for postsecondary success.

### • **End the K-12 Overreliance on Local Levies for Basic Education**

The current levy system penalizes poor and rural districts due to their low property tax bases. A new funding system should correct this inequity.

### • **Make McCleary Work**

As the legislature addresses the *McCleary* mandate, it should ensure that new investments include accountability measures to close the opportunity gap, deliver results, and encourage innovation. The budget can support student outcomes by addressing the following:

- **Improve how we fund schools:** Utilize a student-centered model with enhancements for students and schools with a high concentration of poverty, foster children, and homeless youth. Ensure that funding allocated is used for these purposes and a transparent system of accountability is in place.
- **Improve how we attract and retain good teachers:** Our compensation system should include provisions that compensate educators fairly, address regional cost of living differences, increase starting pay for new teachers, and incentivize teaching high demand subjects and teaching in high poverty and rural schools. Strong professional supports for teachers, paraeducators, and principals should be an integral part of the system.
- **Increase student supports:** We must increase access to supportive, research-based programming and parent engagement efforts. This includes increasing supports for students who are behind, increasing funding for career and dual-credit pathways, bolstering non-academic supports like social-emotional learning, ensuring access to guidance counseling, and partnering with community-based organizations. Staff must be trained and available to support the needs of every student.
- **Improve innovation and accountability:** High poverty schools should be granted greater flexibility in how they use their funds to develop innovative solutions to best fit the needs of their students and communities. Information about how funds are being used should be transparent and accessible so that it is clear how every dollar invested is contributing to improved results for students. Today, it is impossible to track how investments lead to results across the continuum.

### • **Increase Revenue to Invest in Washington's Future**

Washington's nonpartisan four-year budget outlook shows that projected revenue growth will be insufficient to cover increased K-12 education spending needs. With additional resources also needed in early learning and higher education, increased state revenue is a necessary ingredient to achieve the outcomes we desire.

As you do this important work, please recognize that health and human services are essential to meeting the basic needs of children and their families so that they can be healthy and ready to learn. The education continuum cannot be funded by cutting or compromising health and human services. The above priorities align with the Cradle Through College Coalition's principles, which are available on our website:

Thank you for your leadership and continued efforts on the budget. Including these priorities in the final 2017-19 budgets will help advance equity, close opportunity gaps, and improve outcomes for all children in Washington.
